Voluntary Disclosure Scheme: Comprehensive coverage



Udaipur: Chief Income Tax Commissioner, Neena Kumar, was happy to inform that businessmen of Udaipur are most professional in the country. She made this remark while speaking as key note speaker in the joint seminar organized by UCCI in joint venture with the Income Tax Department.

Elobrating theme of Voluntary Income Disclosure scheme, she said that no businessman should be wasting his/her time on fighting income tax cases, paying lawyer fees and taking mental stress,t he best way of dealing with these issues is to ensure that all transactions are transparent and should ideally be done in an online format. She said that in the coming times, all transactions are set to be made online and one should brace for the same.

During the seminar, she gave some interesting pointers on the Voluntary Disclosure scheme. The following were some of the informative points made during the seminar:

- " The scheme was announced in the 2016-17 budget.
- "All information related to the scheme are available on the Income Tax Department website.

"The scheme is applicable for companies, partnership firms, proprietor firms and even individuals

- " The last Voluntary Disclosure scheme was announced in 1997. During that time one had to fill hard copy forms but now all information can be filled online
- " As per the scheme, disclosures need to be made between June 1st 2016 and Sept 30th 2016
- " There is a provision to provide details on both fixed and movable assets
- " The unannounced income could have been gained prior to March 2016
- " One will have to pay 45% Tax (including all cess) on this voluntarily disclosed income
- " Tax needs to be deposited till 30th November
- "Information on Voluntary disclosures made will not be shared by Income Tax department with any other department
- " Provision does not hold for income on which cases have been filed by Income Tax department and matter currently sub

On being questioned by a set of participants that the 45% tax was fairly heavy, Neena Kumar mentioned that as per the current tax structure if one included all the cess on top of the income tax bracket, the tax rate anyways comes around 40% and hence there is only a nominal 5% additional charge being recovered

Travel + Leisure ranked Udaipur among top ten in Asia

Udaipur: readers of US magazine Travel + Leisure in the top 10 Asia's Best Cities for 2016. Voted Udaipur is the only Indian city to feature in the list.

The list is topped by Chiang Mai, Thailand followed by Luang Prabang, Kyoto, Siem Reap, Bangkok, Vietnam's Hoi An, Bali's Ubud, India's Udaipur, Tokyo, and Tibet's Lhasa. Readers rated cities on their sights and landmarks, culture, food, friendliness, shopping, and overall value.

Udaipur was ranked 8th in Asia with a score of 87.19 whereas Chiang Mai topped it with a score of 91.25. Chiang Mai was also rated as the World's second best city.

Globally, the best city winner was US city Charleston, South Carolina, with a score of 91.66, up from second last year and taking over from Japan's Kyoto (89.75), winner in 2014 and 2015.

The city rankings are part of their annual World's Best Awards, which also includes islands, spas, airlines, and cruise lines.

Udaipur: A function was organized at udaipur city railway station obn Saturday for laying down foundation stone Of escalator and lift. Udaipur MP Arjunlal Meena, Mayor Chandra Singh Kothari, Collector Rohit Gupta and udaipur celebraties along railway top officials were present.

In pursuance to our efforts to extend amenities to passengers, an escalator worth rupees 2 crore would be installed at the platform number 1 while a lift with a carrying capacity of 20 persons at a time will be installed between the second and third platform here" Anil Singhal, General Manager, NWR told reporters in a media meet after celebration. Both the structures would help passengers specially the elderly people to move from one end of the station to the other with their luggage easily. The escalator work would be completed by December while the lift may come in operation from October onwards. On the occasion, Smita Singhal officer of the women welfare organization (WWO) of NWR inaugurated a baby feeding room at the station premises. " This initiative aims to provide privacy to nursing mothers and save them from the inconvenience of feeding babies at railway stations. Udaipur is second to have the facility after Ajmer and 25 more stations under the division will have such rooms by December" Singhal said.


Udaipur's one man Army: Dr. P.C. Jain, a medical

Dr. Jain personally aware many people to implement RWH in homes, buildings, apartments, schools, hospitals etc and he helped many students of different schools and colleges for project work on Rain Water Harvesting, Till now 1400 buildings in different areas have installed RWH system under his guidance including RNT medical college and many other Government buildings.

Under his guidance 65 doctors of Udaipur are saving about 1 crore liters of pure rain water every year.



The book on Nani Palkhivala -God's Gift to President



research into the life of one of his closest friends, Dr Dharmendra Bhandari, former associate professor at the University of Rajasthan, was able to tell the story of Nani Palkhivala, the eminent jurist who was called the 'conscience-keeper of the nation'. On 8 July, Dr Bhandari presented the first copy of his book, Nani Palkhivala - God's Gift to India (Biography by a Friend), to President Pranab Mukherjee at Rashtrapati Bhavan.

On receiving the book, President Mukherjee said with evident pleasure, "Nani Palkhivala was a giant. And his annual budget speeches became an institution. Unfortunately, no one could carry on this tradition." He added, "Nani Palkhivala was truly a brilliant man. I still remember how, after I delivered my first Budget, he remarked that it fell below his expectations from me. I wrote to him, agreeing with his remark! You don't see men like that anymore."

"President Mukherjee and Nani Palkhivala had mutual respect for each other, while they had different views on polity and policy," said Dr Bhandari. "The country is privileged to have President Mukherjee preserving and protecting the



new discipline, questions have already been raised about its vulnerability to political misappropriation. Today, the maxim is "Knowledge is Power." So, one who wields this power dominates. Since technology is concentrated in the hands of those who wield power, it is possible that the discourse of Digital Humanities becomes the discourse of the

class that wields power. It may be argued that in a democratic capitalist society, access to technology is open to all. But this is true only in principle. In practice the technology often serves the powerful. Those who hold monetary power and

those who hold political power are often collaborators and in such a situation, the hegemony of academic dominance comes into force. Questions about the racial bias of Digital Humanities have been raised in America itself.

Digital Humanities can play a supportive role in the pursuance of a study of Humanities. But it will take some time before it develops into an independent field of academics

Nonetheless, the importance of the discipline of Digital Humanities cannot be undermined. It is important to acquire a clear understanding of the discipline and make use of its potential in furthering research in Humanities. One should try to be cautious of the pitfalls of using it but ignoring it would not lead to any solution.

Dr. Valiur Rahaman, Assistant Professor in the department of English, Central University of Rajasthan, Kishangarh, Ajmer has endeavored to write a full length book on Digital Humanities. This is a pioneering effort and should be hailed as a welcome step. The book is divided into two parts. The first part introduces the discipline in all its dimensions and the second part reproduces two of the critical articles on the theme.

I am confident that the book will fulfill a need and will be received by the scholars and critics with great enthusiasm.
