Need to Open More Jan Aushidh Kendra in India"

Udaipur: PHD Chamber of Commerce and Industry and Government of India's Drugs Ministry organized a conclave on Prime Minister Bharatiya Jan Aushidh Kendra project in joint venture of Udaipur Chamber of Commerce and Industry.
