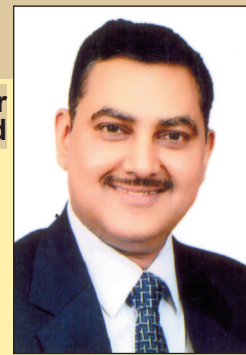

## Opportunities and Challenges of Family Owned Business

In 2016, UCCI began with the single category: Lifetime Achievement Award. The first ever Lifetime Achievement award was conferred upon Late Shri P P Singhal, a legendary entrepreneur or Mewar Region and Founder President of our Chamber.

Initially, the Excellence Awards were instituted for the manufacturing sector and for exemplary work in the field of Corporate Social Responsibility. In February 2017, the awards were conferred upon some of the best enterprises of south Rajasthan.
