Ashish Khatri gets patent for the eco-friendly machine

Udaipur: Ashish Khatri, an emerging scientist from Udaipur, has got a patent for his Banana Peeling Machine.

Ashish claims that it will benefit the environment and will also help in decreasing the effect of global warming by 8-10%.

DSIR department of the government of India has earlier awarded Ashish with a Rs 1 lakh fund under the Technology Entrepreneurship Program. Ashish's achievements also include the "Budding Innovators Award" in 2010, which was given to him by the National Research Development Corporation under the Ministry of Science and Technology.

What is the Banana Peeling Machine

Ashish began work on this machine way back in 2004 when he was a student. This project was undertaken by him under the guidance of Dr. NS Rathore and DR SM Mathur.

The machine peels off banana fiber and can this fiber can be used to make eco-friendly paper.

This machine was first made with wood, to test the effectiveness. Later it was manufactured with metal. The BPM is 10 ft long and 4ft wide. Banana leaves are the raw material for this machine. The machine produces banana fiber out of the banana leaves and these can then be used to manufacture paper, cloth, natural diapers, plywood as well as cattle sterilization medicine and kidney stone medication.

Ashish's invention has also been mentioned in the first blogger magazine, 'Bloggers Park' which is published from New York.

Karnataka: If verdict hung than....

Bangalore: In case of a hung Assembly, HD Deve Gowda and HD Kumaraswamy's party looks likely to ally with the BJP. With elections to the Karnataka Assembly round the corner and the spectre of a hung house a distinct possibility, the real beneficiary in that case will undoubtedly be the Janata Dal (Secular). The JD(S) leadership of the father-son duo, former Prime Minister HD Deve Gowda and former Chief Minister HD Kumaraswamy, is putting on a confident face in asserting they will emerge winner on their own. But the situation on the ground does not tally with this assertion. The other key question is which way the party will go in the event of a hung Assembly. Assuming the Congress and the BJP are neck to neck, all indications are that the JD(S) will go with the BJP. The reasons are widely known. First, there has been personal bad blood between Gowda and Kumaraswamy on one hand and Chief Minister Siddaramaiah on the other. The animosity goes back to the days when Siddaramaiah was with the JD(S) and more importantly was Gowda's right hand man. In 2006, Siddaramaiah called it quits when Gowda sidelined him and promoted his son Kumaraswamy. Siddaramaiah, who joined the Congress, went on to become Chief Minister in 2013.

The successful defiance has never gone down well with the Gowda family. Obviously, they wouldn't want to see the renege continue as Chief Minister for one more term. The other reason for the JD(S)'s possible support for the BJP is that the saffron party's central leadership has already sent feelers to the Gowda family that they count on its support in the event of a hung Assembly. According to one assessment, in the old Mysuru region where the BJP is not yet a force to reckon with, the party appears to have deliberately fielded weaker candidates in several constituencies to ensure that the anti-incumbency vote is not split between the JD(S) and the BJP.

Dr Alok Sharma Professor & Head of Neurosurgery, LTMG Hospital & LTM Medical College, Sion Mumbai and Director NeuroGen Brain & Spine Institute said "A look at the development of the advances in the medical sciences shows that the solutions to difficult untreatable disorders have always come from a multidisciplinary approach. It is only when people from different specialties pool their knowledge, skills and resources, that breakthroughs happen in incurable or difficult to treat medical conditions."

Hiba was born a full-term delivery by cesarean, due to mucus congestion in lungs. She did not cry immediately after birth. All her motor milestones were delayed. She was taken to Children's specialist at around 1 year of age and due to frequent illness where she was recommended to undergo a MRI.

At the age of 1.5 years, Hiba started suffering a series of seizures. The first one lasting for about 5 mins was a silent seizure dur-



ing which she was fisting with froth coming out of her mouth followed by bluish coloration of lips. She was unconscious for 8 hrs post this episode. Physiotherapy was started along with some anti-epileptic drugs. Such occurrences kept on happening with a total of 4 more episodes with almost the same outcome and condition. He was addressing after inaugurating the 'Cochlear Implant Awareness Programme' entitled 'Swar Swagatam' organized by Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment in association with Indian Red Cross Society and Sarvodaya Hospital and Research Centre in Faridabad, Haryana today.

The Minister said that under ADIP Scheme of the Department of Empowerment of Persons with Disabilities (Divyangjan), there is a provision for Cochlear Implant surgeries of Hearing Impaired children's up to the age of 5 years at the cost of Rs. 6.00 Lakhs per unit. After successful Cochlear Implant Surgeries, the child is able to hear and speak like normal Children. He opined that

such awareness programs are of great importance for creating awareness among the public about the Cochlear Implant Programme under ADIP Scheme of the Department.
