"First Successful TAVI of South Rajasthan"

Geetanjali Hospital's Cardiac Team Implant Heart Valve without Surgery Udaipur: Wednesday 27th March, A65-years-old-man is the first person in Southern Rajasthar to undergo Transcatheter Aortic Valve Implantation (TAVI) successfully claimed Geetanjali Medical College & Hospital's Cardiac Team.

The unique procedure does away with the requirement of open-heart bypass surgery. The landmark was accomplished by a team of doctors including Interventional Cardiologists Dr. Kapil Bhargava, Dr. Ramesh Patel, Dr. Danny Kumar, Dr. Shalabh Agarwal & Dr. Anmol, assisted by Cardiac Thoracic Vascular Surgeon Dr. Sanjay Gandhi & Dr. Ajay Verma, Cardiac Anesthetist Dr. Ankur Gandhi, Neuro Vascular Interventional Radiologist Dr. Sitaram Barath, CCU Incharge Dr. Nikhil Singhvi, Cath Lab Technician Lokesh Kumar and Nursing Staff Imran Khan.

The treating Interventional Cardiologist Dr. Ramesh Patel said that the patient, "Lehru Lal Jat (Age 65 years), hailing from Kapasan, had approached the hospital with the complaints of severe breathlessness, chest pain and heart disease that could cause sudden death. On investigations of Echocardiography, it was found that he had a narrowed aortic valve in his heart because of which the valve was squeezing harder to pump blood into aorta (EF was only 20-25%), the main artery supplying blood to brain. He had severe calcified aortic steno-

TAVI, he added, is a non-surgical procedure to implant heart valve (aortic valve mostly) by going from a groin vessel (femoral artery) a tissue valve is implanted by a catheter in a simple procedure similar to angioplasty. It is used on elderly patients who cannot have bypass surgery because of problems in other organs like lungs, liver and kidney. The kidneys of this patient were weak with narrowing of aortic valve.

"People with aortic stenosis cannot undergo open heart surgery due to old age and other complications. For such patients, TAVI proves to be a fresh lease of life without which they would not have life expectancy of more than one year.'

Interventional Cardiologist Dr. Kapil Bhargava said that, "In TAVI, the patient can be discharged soon after the procedure. In this case also the patient was discharged the second

day of the procedure with good biventricular functions. The said procedure can be preferred for intermediate and high risk patients and is better than open heart surgery in certain para-



CEO Geetanjali Medical College & Hospital Mr. Prateem Tamboli congratulated the cardiac team for implanting heart valve without open heart surgery for the first time in Southern Rajasthan. "Now elderly people and other patients who cannot withstand open heart surgery can be benefited from this technique. Geetanjali Hospital has always established itself as a leader for world class innovations. Moreover, This technique is available with only few centers of Northern India, to which Geetaniali Hospital has added its name which is a proud moment for Geetanjali as well as the whole Udaipur City. The patient opted for this procedure are likely to recover early and can get back to their normal life soon. It also helps avoiding post surgery complications (if any). Such patients who are not appropriate for surgery are relatively at a higher risk if taken for surgery," he added.

Lecture on Methodology for field identification of plants

Udaipur: Correct identification of plants are essential for scientific validation of any plant drug and for identification purpose, prior knowledge about relevant flora is also necessary. This was expressed by Dr. Vartika Jain who is working as Assistant Professor, Department of Botany, Govt. Meera Girls' College, Udaipur in a three day Re-orientation training program of Ayurvedic Medical Officers organized at RTDC Hotel Kajri on Wednesday as a Trainer. She was introduced to participants

by Dr. B.L. Jain. Dr. Vartika explained difference between floristic. ethnobotanical and medicinal plant survey and gave important clues for preliminary identification of plants in a field visit. She also explained the technique to properly preserve a plant for making a herbarium specimen and which are the important indexed Herbaria of country where the preserved plant specimen could be submitted and identified correctly. She emphasized on keeping the voucher specimen of a plant/herbal drug before starting any scientific laboratory research on the plant. Various methodologies to document the medicinal importance of the plant species as given by local folk were also explained to par-

Later Dr. Vartika also gave information about various folk medicinal uses of some local plants growing in surroundings of Udaipur for example of city. Further, she proudly informed about the First Indian Book selected for Mary. W. Klinger Award Finalist 2017-18 by prestigious Society for Economic Botany, USA which is 'Compendium of Indian Folk Medicine and Ethnobotany' 'containing concise information on ethnobotany of about 4600 plant species growing in India and authored by her and Dr.

There were 40 Ayurvedic Medical Officers from all over Rajasthan who attended the course and asked their queries about difference between collection of fresh/dry plant part, some suitable areas of Rajasthan for collection of particular medicinal plants etc. and Dr. Jain served them with proper answers. In the end, Dr. P.L. Choubisa extended her heartfelt thanks to her for delivering lecture on such an important topic relevant in present context when plant diversity is depleting rapidly and experts in plant identification are also
