Sarang family raga's, Kalyani and Charukesi work amazingly well for heart blockages and other heart diseases.

Headaches

Raga Asaveri, and Poorvi are drugs to get rid of headaches. Raga Todi is necessary for headache due seasonal colds, while Raga Asavari also holds good for psychological disorders. Raga Bhairavi helps cure headaches for Sinusitis. **Diabetes**

Raga Bageshri and Raga Jaijayanti for diabetes whether you are at a borderline or on insulin

Jallianwala Bagh Massacre staged

On 13 April 2019, exactly 100 years back India suffered a hard wrenching encounter in one of its major state, Punjab. It was the well knownJallianwalaBagh Massacre in which hundreds of people were killed. There were thousands and lakhs of people all around the Nation were in deep torment. But what did happen? That such an exorbitant bloody event took place? Why Brigadier-General Reginald Edward Harry Dyer ordered to fire upon the peaceful procession of unarmed Indians. Many among them had come to enjoy the Baisakhi fair?

On this distressful day of the 100th anniversary, artists of Natyansh Society of Dramatic and Performing Arts presented an improvisational act named 'Dastan-e-JallianwalaBagh' at Natyansh's workplace, Sadri Haveli. The act aimed at acknowledges the audience, who would know the consequences that led to the massacre

Play began with dyer's trial by Hunter committee who questioned him about the massacre where he simply states that what he did was 'Merciful though Horrible'. The play then takes us little back in time before the incident, when some people of Amritsar planned a strike against Rowlatt Act under the leadership of Dr. SaifuddinKitchlew and Dr. Satyapal. They both got arrested and were sent to Dharamshala (a place in Himachal Pradesh) on 10th April 1919. The news of their arrest evoked the people of Amritsar. They went to meet the then Lieutenant Governor General of Punjab Sir Michael Francis O'Dwyer, who refused to meet people. The angry mob started attacking government building, banks, and railway stations, etc. killing some British people and even assaulting British females one of whom was Marcella Sherwood. To take the situation under control O'Dwyer called Brigadier General Reginald Edward Harry Dyer from Jalandhar. Dyer arrived in Amritsar on 11 April and implemented Martial Law in Amritsar on 12 April and restricted meeting more than 3 persons in a single place. Baisakhi is a sacred festival of Sikhs and every year a Baisakhi fair was being organized in JallianwalaBagh. Unaware of Martial law many people from various places of Punjab visited this fair. Also, thousands of Hindus and Muslims gathered to discuss demolishing Rowlett act and freeing their leaders Satyapal&Kitchlew from Britishers. When Dyer came to know about the gathering, he went to fair and started firing on people without prior warning.

Play started developing the point of climax when the massacre was enacted and it ended with bodies of innocent people lying everywhere. The artists' faces turned from sudden shock and terror to nothingness. At last, one after the other questions were raised by the artists leaving the audience in an inevitable cycle of thoughts rooting from "Have we in a true sense been able to achieve freedom?"



Rang Samwad, an interaction with the audience was organized after the play in which they expressed concern over the current situation in the country and said that aware youth can lead our country on the right path, so they must come forward for discharging responsibilities.

Udaipur were able to successfully operate a twenty one years young girl with an enlarged spleen measuring 25 centimeters & weighing 2.5 kilograms. She had a potentially lifethreatening condition called, Extra Hepatic Portal Vein Obstruction (EHPVO), blocking the blood flow between the intestines and liver. She was then operated by removing the enlarged spleen by performing surgery named "Proximal Spleno Renal Shunt with Splenectomy (PSRS)."The team of successful surgery comprised of Gastroenterologists Dr. Pankaj Gupta & Dr. DhawalVyas and GI Surgeon Dr. Kamal Kishore Bishnoi. The team was assisted well by Neuro Vascular Interventional Radiologist Dr. SiataramBarath, Anesthetist Dr. S SJaittwat, Dr. Lalita& Dr. Bhagwant and OT In charge HemantGarg.

GI Surgeon Dr. Kamal Kishore said that, "Patient PriyankaSalvi (Age 21 years) Dungarpur Resident, reported at Geetanjali Hospital with weakness and acute stomach ache. On investigations of Ultrasound, Endoscopy & CT Scan she was confirmed with Extra Hepatic Portal Vein Obstruction. This disease is common in young patients and shows with symptoms like blood in vomits, weakness, growth retardation etc."

"With only 6 grams hemoglobin and a low TLC count & platelets she was recommended for surgery. As the spleen was enlarged to such an extent, the hepatic portal vein transporting blood containing vital nutrients from intestines, where food is break down, to the liver for further digestion was blocked. Blockage or reduced blood flow through this major vein can lead to malnutrition, bleeding and death. This blockage leads to initiation of small veins to carry blood into liver with high pressures. This medical condition is termed as Asymptomatic Portal Biliopathy," said the treating GI surgeon Dr. Kamal.

"A corrective procedure was then alleviated in which the artery of spleen was closed. As soon as the artery was closed, the blood in the whole body was circulated through splenic vein which made the hemoglobin raise up to 11 grams and the surgery was carried without any blood transfusion. This vein was then transplanted into renal vein and normal blood flow was reestablished allowing the blood to

Udapur AIFUCTO demands 10% of GDP for Education, RUCTA demands implementation of VII pay in all institutions from 1/1/2016

Dr.H.S.Chandalia, The National Executive Council of the representative body of the teachers of higher education All India Federation of Universities and College Teachers Organizations met on 6-7 April, 2019 in Udaipur. This meet was accompanied by a National Seminar on " Present Scenario of Higher Education in India and Future Prospects". The two day programme was hosted by Sukhadia University Teachers Association and Rajasthan Universities and College Teachers Association (RUCTA). The Executive meeting of RUCTA also took place on the evening of 6th April. NEC members from all over the country participated in the seminar and the meeting. The seminar on 6th April was chaired by the Vice Chancellor of M.L.Sukhadia University Prof. J.P.Sharma while the NEC meeting of AIFUC-TO was chaired by the President of AIFUC-TO Prof. Keshab Bhattacharya. The issues like autonomy of institutions of higher education, implementation of VII Pay commission recommendations uniformly all over the country, recruitment of regular teachers, pension scheme for teachers, research and development grants, check on saffronization of syllabi and the creation of the post

Universities and College Teachers Association (RUCTA) Dr. Vijay Ary said that RUCTA will demand the implementation of VII Pay Commission recommendations in all the institutions of Higher Education of the state from 1/1/2016.

The two day event was inaugurated by Prof. IndravardhanTrivedi, former Vice Chancellor of Mohan LalSukhadiaUniversty. In his address he said that the access, excellence and approach of education are three factors which need to be taken care of. Despite repeated demands of the universities the permission to recruit teachers is not given by the state governments, he complained. The inaugural session was chaired by Prof.J.P.Sharma, Vice Chancellor of M.L.Sukhadia University, Udaipur. In his address he stated that the higher education institutions are facing inspector Raj. A number of agencies have been made to evaluate universities but the universities are denied funds to meet their expenses. He said that students should equip themselves with the necessary knowledge and skills which can enable them to find a place in the job market.Prof. Dariyav Singh Chundawat , former president of Sukhadia University Teachers Association described the contribution of teachers organizations in upholding the values of education and fulfilling the aspirations of the teaching fraternity.

The key note speaker Prof. Rajib Ray, President of Delhi University Teachers Association and also of FEDCUTA talked on length about the present scenario of higher education in the country and expressed concern over the policy of the union government to privatize and corporatize higher education. He said that the budget for higher education has been reduced from 0.67% to 0.45%. The government is promoting private sector at the cost of public institutions. 60% of the Gross Enrolment Ratio is in the private sector. The fees hike in IIT from 40 thousand to 2 lakhs in last few years is a sign that higher education is being reserved for the elite class. President of All India Federation of Universities and College Teachers Association Prof. Keshab Bhattacharya said that the scenario of higher education in the country is very bleak. About 2,34000 teaching posts have been reduced in the last five years and out of 180 new universities 129 have been started in private sector. There is a massive attempt to privatize,

in the budget of UGC and now the Union government is planning to change the very system of grants replacing it by the system of loan. This will ultimately destroy public funded education and pave way to complete privatization of higher education in India
