



A Pragmatic Fiscal Blueprint Balancing Priorities in India's Interim Budget

The recently presented interim Budget by Finance Minister Nirmala Sitharaman lays out a fiscal strategy that mirrors a government poised for a potential reelection and steadfastly focused on long-term economic objectives. This budget underscores the government's commitment to fiscal consolidation and an emphasis on capital expenditure, sidelining populist measures. As the country gears up for the General Election, the blueprint places a strong emphasis on sustainability and responsible financial management.

One of the pivotal aspects of this budget is the commitment to reducing the fiscal deficit. For the fiscal year 2024-25, the government has set a target of 5.1 percent of the GDP, a noteworthy reduction from the revised 5.8 percent for 2023-24. The fiscal deficit, a key metric indicating the variance between total government revenue and expenditure, is a barometer of potential borrowings. The government aims to bring this figure below 4.5 percent of the GDP by the financial year 2025-26, signaling a disciplined approach towards managing the country's finances.

In a bid to stimulate economic growth and align with the vision of a 'Developed India' or 'Viksit Bharat', the budget proposes a substantial 11.1 percent increase in the capital expenditure outlay. The allocation for capital expenditure is set to rise to Rs 11.11 lakh crore in 2024-25, constituting 3.4 percent of the GDP, compared to the previous fiscal year's allocation of Rs 10 lakh crore. This push in capital expenditure is integral to the government's strategy, linking infrastructure development with employment generation.

Interestingly, the Defence Ministry takes the lead in allocation with Rs 6.2 lakh crore, underscoring the government's commitment to bolstering national security. On the flip side, the Ministry of Agriculture and Farmers' Welfare, with an allocation of Rs 1.27 lakh crore, finds itself ranked below several other ministries. Despite expectations, the interim Budget doesn't introduce fresh impetus to the agricultural sector, and the government largely reiterates the success of existing schemes.

The budget refrains from offering tax relief to the middle class, maintaining the status quo in various tax slabs. This decision underscores the government's determination to sustain the momentum in tax collections, which, according to the Finance Minister, have more than doubled over the past decade.

While lacking headline-grabbing announcements, the interim Budget encapsulates the government's self-assured approach, potentially perceived by critics as complacency. As India navigates its economic trajectory, the pragmatic fiscal measures outlined in this budget set the stage for a balanced and sustainable financial future, irrespective of the electoral outcome.

In response to the interim budget announcement, Shri Ashish Kumar Chauhan, the MD and CEO of the National Stock Exchange (NSE), has given it a top rating of 10 out of 10. He commended the budget for its consistent focus on policies, fiscal discipline, and a centric approach towards development, welfare, and economic prudence. Chauhan highlighted

the emphasis on capacity building through increased spending on infrastructure, aiming to create employment opportunities. The budget is notably geared towards the welfare of the poor, farmers, women, and youth, signaling a positive direction for overall economic development.

He acknowledged the budget's efforts to achieve fiscal consolidation, with a revised



estimate indicating a 5.8% reduction in the fiscal deficit for the financial year 2023-24. Looking ahead, there is a commitment to reaching a target of 4.5% fiscal deficit by the financial year 2025-26.

The record-high expenditure of ₹11.11 lakh crores, a 16.9% increase in capital expenditure, has been directed towards various sectors, particularly roads, trans-

portation, and railways. This allocation, representing 3.4% of the total GDP, is the highest in the last 26 years, focusing on a special push in the past five years, resulting in a 27% compound annual growth rate (CAGR). Chauhan noted improvements in the quality of expenditure, with capital expenditure now constituting 23.3% of the total expenditure, the highest in the last 30 years.

The budget addresses critical areas such as electricity, healthcare, housing, cooking gas, and financial inclusion, providing social security frameworks for the poor and needy.

Summing up, Shri Ashish Kumar Chauhan deemed the budget as positive for the markets, highlighting the continued focus on development, prudence, and transparency.

Resolute Commitment towards Developed India - Deputy Chief Minister Diya Kumari

Udaipur: A budget of INR 553.90 crores has been approved for smart development projects in four cities of the state under Smart City Mission Phase 2.0. Udaipur, allocated a sum of INR 134 crores, received the approval from Deputy Chief Minister and Finance Minister Diya Kumari on Wednesday.

Deputy Chief Minister

Kumari emphasized that Smart City Mission Phase 2.0 aims to facilitate smart development projects in Udaipur, Jaipur, Kota, and Ajmer, with a total investment of INR 553.90 crores. She expressed gratitude towards Prime Minister Narendra Modi and Minister of Housing and Urban Affairs Hardeep Singh Puri for their support.

She highlighted that under the leadership of Chief Minister Bhajan Lal Sharma, the state government is working diligently towards realizing the goals of Prime Minister Modi's vision for a developed India. The allocated funds will be utilized for the foundational development of key structures in the four major cities, ensuring the citizens benefit from the advan-

tages of a smart city.

Notably, the approved budget includes INR 134 crores for Udaipur, INR 154 crores for Jaipur, INR 168 crores for Kota, and INR 98 crores for Ajmer under Smart City Mission Phase 2.0. This funding will be instrumental in the development of basic infrastructures, with a special focus on integrated waste manage-

ment.

Interim Budget Focuses on Youth, Poor, Women, and Farmers, No Changes in Tax Slabs

Udaipur: C.A. Nirmal Singhvi, former president of Udaipur Tax Bar Association, highlighted that the interim budget presented by the Finance Minister remains focused on the youth, the poor, women, and farmers. He noted that while there were no changes in the tax slabs, the budget is supportive of the nation's all-encompassing development. Singhvi welcomed the provision to install solar systems on rooftops, offering up to 300 units of free electricity per month, potentially resulting in annual savings of ₹15,000 to ₹18,000 per family. The decision to refund direct taxes for certain financial years and the increase in capital expenditure were also seen as positive steps. The revised estimate of fiscal deficit for the financial year 2024-25 is set at 5.1% of the GDP, which is considered favorable despite lower growth projections. Singhvi also highlighted the provision of interest-free loans amounting to ₹75,000 crores for development in states as a positive aspect contributing to their progress.
