

Rape culture or not, it is we who decide!

A few days back, while traveling to my office, I met a woman — about five years older than me, a dancer, an ambitious model, a fun-loving and spiritual person. We happened to get along randomly! On our way towards Okhla Bird Sanctuary metro station, we continued talking — about life, parents, passion, goals, friends, traveling, etc. We exchanged numbers and texted back in a few seconds after separating.

That day was one hell of a day!

I got late while leaving from work and dropped the chance of meeting her while traveling back to Gurgaon. I boarded the metro and took my preferred spot (near the door). I habitually listen to music while onboard, but not that evening. That evening, I was just pondering, stressing my nerves so strong, just recollecting what that gorgeous woman had said earlier in the day.

What she stated will hit you strenuously and I'm gonna quote it without altering, "You know, I asked my brother last weekend — what are you most afraid of when you are out? (like traveling or shopping or partying till late) His response was simple — I am just terrified that no one snatches my phone! Or I seldom dodge encounters as I am frightened as hell towards any threats. I was like — nothing more? To which he responded NO."

"Now, imagine how much alarmed I am? I have to take care of what I am wearing and have to keep myself conscious perpetually — is my strap visible, am I resting in the right position. I have to hold that nerve full of anxiety and walk quicker when I am alone! People talk about gender equality and feminism and numerous other things. I think when this atmosphere transpires from every woman's inner self, that day I will approach gender equality as a reality and not merely a notion (which it currently seems to be)"

Throughout my 1:30 hours of the course, I just kept on looking for explanations and peeked into myself as to how much have I made a girl protected. It could have been very easy for me to put on some stories on Instagram and Snapchat, and censure the society, the mentality, the upbringing, the families, the friend circle, etc.

Has that helped? Ask this question to yourself again? Has this exercise helped any woman of the nation? Did any of your female friend mention about feeling protected and unharmed even around 7 pm?

A limited response could be yes! But a conventional answer each individual would have — Never!

It's remarkably good how the youth is utilizing social media today, that's commendable. But, just put your-

self in the thought of leaving from your friend's place late or from office/tuition, what is the first notion that appears in your consciousness?

It's the anxiety that sinks in that makes you vulnerable and low on self-confidence, which can be critical.

The new season of Ted Talks India — Nayi Baat presented a lot of female voices who are striving towards gender equality and sexual violence. But the most significant speaker — Madhumita Pandey (a doctoral researcher and a lecturer in criminology) just caused chills to me. She reached with an answer to the question which every Indian asks — "Why do men rape?"

She interviewed more than 100 convicted rapists in Tihar Jail for her doctoral thesis. She followed the ethical guidelines which were set by the British Psychological Society and examined only the willing participants. Questions such as — 'do you masturbate? When did you first have sexual intercourse? Did you ask for consent?' were asked and the results, clearly not shocking!

What her research stresses on is extremely insightful and is accurate to the point that we humans manage to overlook issues on the other side of the nexus such as everyday eve-teasing, debasing language against women, sexist jokes, and harassment. Long-term precautionary measures



shall include the society's locus on these less alarming issues, which ultimately lead up to intense violence or build tolerance towards it. She has advised the society to shift towards structural changes that address the asymmetric power relationship between men and women in the country.

The dilemma of lack of personal identity among women (especially in the rural communities) necessitates the education and empowerment of women while guaranteeing the development of a healthy perception of masculinity amidst young men.

Socio-cultural influence and conventional gender roles play

pivotal roles in subjects such as victim-shaming, toxic masculinity, and rape culture.

Another element that is more prevalent amongst sex offenders — 'victim-blaming'. It is a very common phenomenon that demands to be replaced. Sex offenders in their narratives effortlessly put a question mark on the victim's character. How can it be improved? Or how can the rape culture standstill?

The key to this barrier lies in education — Sex Education!

In India, there is a distinct perception among people when the word sex drops in. It is nothing to be embarrassed about; we agree to it, yet we manage to evade conversa-

tions on the topic with our family members. Why?

This draws in a lot of discomfort but proffers birth to the idea of 'lack of awareness'. The outcome of this is pretty candid — many in our country don't even realize the term 'consent'.

From the birth of a man, until he is grown, it is a very complex period and usually in our country, he experiences privileges such as autonomy, mobility, opportunity, and power. The most amusing factor is that these privileges are reckoned to be only enjoyed by men and not women. Women instead start to endure restrictions.

We are yet to have a nationwide campaign focusing on

educating our people towards sexual violence and exploitation, and changing everyday misogynistic viewpoints.

Educating young boys and girls (both rural and urban) will enable them to understand their bodies, age-related changes, the meaning of consent, respect one's personal space, menstruation, sexual intercourse, sexually transmitted diseases, and risks of pregnancy. Also, it would be more meaningful if parents are committed to this process at the very first point. Parents should start educating their children gradually with age, which will incur a greater sense within them from the very beginning.

Putting up stories and comments on social media platforms is okay! But what is more important right now, at the moment, is people stepping up on such agendas. If you can put up a good message/caption on social media, then you are certainly capable of doing much more!

Trisha Shetty, an Indian activist, runs a non-governmental organization called SheSays which concentrates on ending gender-based discrimination and the advancement of women's rights in India. Her NGO has supported rape survivors and their families with medical and legal aid (at times financially too).

People like Madhumita Pandey, Trisha Shetty, and many more are working

towards such subjects and require everyone to support them and help India become a rape free country.

It is a tough job and not an easy one! But just reminisce about everything which appears in your mind being an Indian — rape culture, a dangerous place for women, lower ranking in terms of women's inclusion and well-being, one of the countries with the highest number of crimes against women, etc.

Four women are raped every hour in India. The real stat could be much higher.

I am just pushing each one of you to stand up and deem about taking an action that might be conducive to many and even yourself. Questioning the government, or the law, on taking action is probably evident to each one of us. But, we not being part of the developing process are equally culpable for the before-mentioned acts.

I have myself engaged with such NGOs and people dealing with human rights advocacy and gender policies. Please, step up and start taking productive actions, which can direct to the prosperity of our nation. This might not be the ultimate answer to the most prominent dilemma of the nation, but it could be multiple steps up the ladder to arrive at the coveted stature.

Think and act smartly people! This is what young India is supposed to do!

Unemployment dole: 40% women among beneficiaries in state

Jaipur: About 40% of youth who are getting the unemployment allowance in Rajasthan are women, according to the data released by Skill, Employment and Entrepreneurship Department.

According to the department data, Rajasthan government provided unemployment allowance to 1.5 lakh youth in Rajasthan till December 15, including 60, 563 women. Among the total beneficiaries are 994 handicapped persons. The total amount disbursed so far is Rs 224 crore.

Dr Samit Sharma, commissioner of the skill and employment department, said the number of women who have

benefited from the scheme is "very encouraging". "It is a way of empowering them," he said.

The caste-wise break-up of the beneficiaries shows 111,464 from the general and OBC category, 22,115 from the scheduled castes (SCs) category and 16,611 beneficiaries from the scheduled tribes (STs) category.

The district-wise break-up shows that the highest amount has gone to Sikar, which has got Rs 29 crore, followed by Alwar (Rs 16 crore) and Jhunjhunu (Rs 15.9 crore) and Jaipur (Rs 15.57 crore).

The lowest amount went to Pali, which got Rs 49 lakh, followed by Barmer

(Rs 54 lakh), Jaisalmer (Rs 76 lakh), Pratapgarh (Rs 77 lakh) and Chittorgarh (Rs 85 lakh).

Sharma said the districts with a higher proportion of educated youth have sent in more applications and so the sum disbursed to them is more.

"In Sikar, Jhunjhunu, Jaipur, youth are more educated and aware as compared to Pali or Jaisalmer, so more applications are received from these districts," he said.

Before coming to power, the Congress government had announced the unemployment dole for the youth. Chief minister Ashok Gehlot in the 2019-20 bud-

get had announced that Rs 3000 allowance would be given to unemployed men and Rs 3500 to unemployed women from March 2019.

The government set a limit of 1.6 lakh beneficiaries per year and allotted a budget of Rs 524 crore under the scheme.

As per the eligibility criteria, any unemployed graduate whose family income is less than Rs 2 lakh per annum is eligible. The allowance will be given for a period of two years.

The official said that under the previous BJP government, a total of 1.56 lakh beneficiaries got the allowance and a sum of Rs 121 crore was disbursed.
