Dr. Harsh Vardhan visits Lady Harding Medical College Hospital to review status of COVID-19 management

"Increasing recovery rate reflects the quality of care provided by our frontline health workers in India": Dr. Harsh Vardhan

New Delhi: The Union Minister for Health & Family Welfare, Dr. Harsh Vardhan recently visited Lady Hardinge Medical College, which is one of India's oldest and established medical college, to review status of COVID-19 management. Keeping in view the emerging requirements for hospital preparedness, Lady Hardinge Medical College, is functioning as dedicated 000bedded COVID-19 hospital

consisting of adequate isolation wards and beds

The Union Minister visited the Director's office, emergency, sampling center, COVID block, lab flu corner, isolation wards, observation wards, critical areas/ICUs, COVID corridor, COVIDArea, COVIDOPD, Red zone area, changing facility for doctors and health workers,. At the sample collection center he saw the whole process in details of samples

He was satisfied to notice that the doctors and health staff manning these wards are provided special bathing, changing and spray facility for disinfecting themselves at Oncology building. The facility for boarding and lodging are provided to the health workers in few hotels nearby to avoid the issues of transportation and

prevent the exposure to their families

At the COVID ward, the Minister spoke through video call to a patient who was admitted at the facility. The Minister said "I am happy to learn that he is hale and hearty and recuperating well at the hospital. It is very encouraging to see his high moral despite suffering from COVID.

After a detailed review and inspection of the various wards and premises of the Hospital, he expressed satisfaction at the working of the various unit. He stated: "In last few days. I have been visiting various hospitals AIIMS (Delhi), LNJP, RML, Safdarjung, AIIMS Jhajjar, Rajiv Gandhi Super Specialty and now Lady Hardinge Medical College to review the preparedness of COVID-19 and Lam satisfied



with the arrangements made by these hospitals to deal effectively with the outbreak".

Commending the frontline caregivers such as nurses, doctors and other healthcare personnel for the resilience, hard work, dedication and commitment shown by them in dealing with COVID-19, Dr Harsh Vardhan said, "The recovery rate of COVID-19

patients has steadily increased from 00% in the week ending April 00 to 12% in this week. This shows that more and more of these patients are getting better and going back to their homes. It reflects the quality of care provided by our frontline health workers in India. I congratulate them for this success. The country is grateful to you for your services

in such times. It is heartening to see the high morale of our health warriors in these testing times."

Dr. Harsh Vardhan also stated that the prevention, containment and management of COVID-19 in the country is being monitored regularly at highest levels in collaboration with the States. He said, "The rate of growth of new cases has also been steadying for a

Before the lockdown, India's doubling rate was about 3 days. As per the data received today by 8 AM, over the past seven days, the doubling rate is 7.2 days, for the past 14 days it is 6.2, and over past 3 days it stands at 9.7.

This is despite the fact that number of tests done every day has increased by almost 14 times. Same way, if you look

at growth factor - from 15th March to 31st, it was 2.1, whereas in April it has come down to 1.2 which is a good drop of 40% which is a positive indication and is really encouraging for the whole country.

"This also indicates that the total number of COVID-19 cases are increasing and we need to adhere to strict physical distancing and basic hand hygiene etiquettes in letter and spirit to take lockdown 3.0 to a logical end," he added.

Dr Harsh Vardhan urged the people of India to observe the extended period of lockdown 3.0 (till May 17, 2020) in letter and spirit and treat it as an effective intervention to cut down the chain of transmission of COVID-19. "It is important to follow hand hygiene, like washing hands with soap and disinfect and regularly clean all frequently touched surfaces. Everybody should wear a mask or face cover as appropriate; download the Corona tracker app "Arogya Setu" for self assessment of risk; and

maintain physical distancing." He said by observing discipline in day to day life during Lockdown 3.0 would reap us rich dividends in terms of turning the tide against COVID-19. "We are on the path of success and we will win this war against COVID-19 in toto".

The Director General Health Services (DGHS) Government of India, Shri Rajiv Garg and Director, Lady Hardinge Medical College Dr. (Prof) N.N. Mathur accompanied the Minister during his visit to the hospital.

Do not consider the waiver of Lockdown - Collector

Bhilwara: District Collector Shri Rajendra Bhatt, has issued an order clarifying that exemption in LockDown does not mean that LockDown has expired. Districts should follow the guidelines of the central and state government to maintain the public down.

According to the District Collector, Lock Down 3.0 is applicable in the whole country. In this sequence, separate provisions have been made in the Bhilwara district with the permission of the

In areas other than strict prohibitory areas, the provision of a modified public down will be applicable as per the instructions of the state government. LockDown has not ended in the district, and all activities are prohibited except for permitted activities. Only those possessed by the per-

In the order, the public has been advised to leave the house only after obtaining permission if necessary and to follow the medical protocol and social distance. The District Collector has appealed to the enlightened people, state officials and personnel, voluntary organizations, social

this, his leg bone was not connected. Bone grafted to add his bone to this, but that too did not work. In two years, the plate in the patient's leg was broken, and there was tediousness in the leg. He was unable to walk due to pain and a broken bone in his leg.

On this, his family had taken him to GBH American Hospital recently, orthopedic surgeon Dr. Prashant Maheshwari, conducted various tests of the patient, the plate was broken, and the bone was not found. It was decided to re-operate on this. In it, the patient removed the broken plate from the foot and was implanted in the ellipse ring fixator while performing a complex operation to connect the leg bone. The very next day, the patient was run over with a walker. Dr. Prashant Maheshwari said that by giving physiotherapy continuously, the patient would be run without a walker in the next two weeks.
