## A Monsoon palace with breath-taking panoramic views and exquisite architecture

#### The highest point around Udaipur and home to rare wildlife

Perched at the top of the highest hill of Girwa Valley, 936 metres above main sea level and 343 meters above the surrounding country, Sajjangarh Palace is 5 km in the west of Udaipur. Visible from a great distance the palace offers a breath-taking panoramic birdeye view of the Udaipur city, Picchola and Fatehsagar lakes, distant villages, palaces and hill ranges. Words cannot describe the beauty of this scene adequately. It has to be seen to be believed. Once covered with dense vegetation, the Bansdara hill had five odis shooting boxes, constructed around it to facilitate hunting and to have a view of the forest area. It is said that Sajjangarh played an important role in the Heliography system of transmitting messages

about royal hunting in the erstwhile Mewar state. These messages were sent to Jaisamand via Udaipur. It is said that it was built to monitor the approaching monsoon clouds. The hill was full of wildlife. The last royal hunt of a 9 ft 7 inches long tiger in 1956 is on record.Maharana Sajjansingh himself designed it as a twelvestory building so that the light of Vijai Stambh of Chittorgarh could be seen from here. He started construction of this palace to house an observatory. However, it is believed that this fortress was designed and constructed in the style of royal buildings of Hyderabad Deccan. The Maharana died prematurely and the plans were curtailed when only after a few storeys had been built. To decorate the palace he had ordered, products made of crystals from Belgium. 1899 A.D., Maharana Fatehsingh completed the buildings that has apartments for ladies and gents, a large courtyard and stables, rooms for servants and personal staff and enclosing walls. The delicate carvings on the stone in the first storey are extremely interesting. The smooth shining walls of lime plaster, marble pillars engraved with leaves and flowers, 'jharokhas', domes and fountains are living evidence of art and architecture of this region.

It is thrilling to see such a massive construction at such a height done during the old davs when no mechanical means were available for such activities. The palace has importance also because of its safety. It served as a roval resort during the rainy season and a place of outdoor recreation apart from hunting.

The palace is also a model of rain water conservation. Every drop of rain water falling at any part of the palace is being tapped and stored in the

huge water storage tanks with capacity of 312723.3 litres that even today poses a challenge to modern architects.

With the beginning of rainy season kissed and caressed hovering clouds. bγ Sajjangarh, also popularly known as Monsoon Palaces comes alive and appears as if the fortress is hanging in the sky. Sunsets here are absolutely fantastic.

Undoubtedly, it is one of the best place to visit in Udaipur.

#### Health protocol should be strictly followed in traffic -Chief Minister

Jaipur: The state government has continuously taking steps to overcome the practical problems of the people during lockdown and corona transition. Due to this, exemption has been given to the workers, migrants, and business activities. But at the same time the Government is also fully aware of the rising corona positive cases from traffic. The government is also cautious about the possible transition from regular air and rail traffic to further opening. Therefore, in the coming times, all health related protocols including guar-

antine will be strictly followed. Chief Minister Shri Ashok Gehlot has said that in view of the increase in the number of corona infected patients due to increased migration of migrants / workers, despite the exemption in the guarantine rule for



the passengers going from one state to another state by the Government of India. In all, the rule of staying in quarantine for 14 days will be fulfilled. He said that for those travelers who stay in Rajasthan only for a few days, it will be mandatory to get RT-PCR test before coming here or as soon as they arrive here. Such a person will have to stay in quarantine till the test report comes negative.

Shri Gehlot was presiding over a high-level review meeting with officials at the Chief Minister's residence on Sunday. He said that in the last few days more than 1 million migrants have come from outside in Raiasthan, out of which about 1600 have been found infected. More than 50 percent of these migrants have not completed their guarantine period. In these circumstances it is necessary to strictly adhere to the health protocol for the safety of everyone, including local residents and visitors.

The Chief Minister said that the State Government is giving priority to home quarantine for the convenience of migrants and their families. But due to lack of home guarantine facility, the State Government has made a strong system of institutional guarantine up to village level. He appealed to all visitors coming to Rajasthan by air, rail and road to register the necessary information including mobile numbers by registering online on e-Mitra portal of Rajasthan Government. Due to this, proper arrangements can be made for health check-up and treatment of a person if he is infected with corona or shows any symptoms.

Mr. Gehlot instructed the officials that all the people coming from outside should be monitored with IT based system and they should strictly follow the instructions to quarantine them in home. The list of passengers coming by airplane, train, the list of railway and bus passengers from Rajasthan Roadways should be sent to the concerned district administration so that effective monitoring of passengers can be made

In addition to this, the facility of registration and quarantine will also be available to people entering the State by road on the earlier border checkposts.

Moksha Kalash Special free bus service starts today Shri Gehlot said that for those whose bones have not been immersed during the lockdown, the State Government has started Moksha Kalash special free bus service. The first special bus will leave on Monday. Two people will be able to go with a vase and they will have to register themselves on the portal of Rajasthan State Road Transport Corporation. He said that this initiative has received good response from general public across the state. The senior citizen pilgrimage scheme launched during the time of our previous Government also benefited a lot. On the same lines, the benefit of this scheme should also be available to the people waiting for immersion of their family member's bones. However, it is a very sensitive subject for many families


