Nation Suffers With Current Unemployment Burden Needing Strategic Recovery Mechanisms

hile making way to recover from the shattering multi-dimensional damage as faced during two year long Covid-19 crisis, another pressurizing record is added in the current crisis portfolio of India. The country's unemployment rate gone up to 7.83 per cent in April this year from the the stage of 7.60 per cent noted in last month.

Both urban and rural areas have come under the burden of this current fall-down of employment. The rate of urban side joblessness increased from 8.28 per cent (March'22 record) to 9.22 per cent in April.

Rural joblessness rate has rose to 7.29 per cent from 7.18 per cent. Earlier, in Lockdown



times, the joblessness figure rose due to the nationwide movement restrictions. This time, as the report of CMIE explains the challenge arrives out of drop in domestic market demand.Based on the decline of labour participation statistics of 2017-2022, CMIE has marked that the lowering from 46 per cent to 40 per cent is an outcome of loss of job seeking interests, particularly located among the young work-

force. Mostly, as the report observes, the latest poor rate of employment is happening from the long spanning frustration and fatigue among the eligible mass, including females. In the current job market, only 9 per cent of capable females have obtained fresh income option.

Now, on the existing number of about 2 crore people without their jobs during the pandemic time, a fall of at least

12 per cent of GDP in two consecutive Covid waves if the current figures are added, that makes the Government's promised job creation efforts and assistances to be too feeble to improve the situation. It is really urgent to develop alternate livelihood scope, diversification of employment segments and provisions of support options to be open for the suffering mass.

1.70 lakh milk farmers from Rajasthan seek CM's intervention for their inclusion in the Mukhyamantri Dugdh Sambal Yojna

Udaipur: 1.70 lakh milk farmers including 70,000 women from 4 organizations created by the farmers on cooperative principles, today sought Rajasthan's Hon'ble CM Shri Ashok Gehlot's intervention for their inclusion in Rs 5 per litre cash support scheme of the state government.

"The disparity created by their exclusion from the scheme could pose serious hardships for us and could even kill the livelihood of thousands of our members", Chairperson of these milk farmers' organizations represented by Smt. Mamta Chaudhary, Paayas Dairy, Jaipur, Smt. Manjeet Kaur, Sakhi Dairy, Alwar, Smt. Kanya, Asha Dairy, Udaipur and Smt. Anju Kevat, Ujala Dairy, Kota said in a joint statement.

To provide financial help for the welfare of milk producers of Rajasthan, "MukhyamantriDugdh Sambal Yojna" was announced in the FY19-20 state budget, under which the state government gave a grant of Rs 2/- per litre to the cattle owners for supplying milk in the cooperative milk producers' unions of the state. In the recently presented budget of the fiscal 2022-23, it has been announced to increase with subsidy on milk from Rs 2/- per litre to Rs 5/- per litre under the said scheme. The four organizations have been established by the dairy farmers by investing their own money as share capital. They said that these four farmer organizations jointly collect over 10 lakh kilograms of milk every day from their members for which payments are made directly into their bank accounts in a cycle of three times a month. The four organizations have together paid a total of Rs 8,732 crore to the members, by way of milk price, cash incentive and dividends, since the first organization began operations 10 years ago. In addition to the remuneration received by members on behalf of milk poured, these members receive cash incentives and dividends. As a policy, none of these organizations collect milk from anyone who is not a member/shareholder of the organization. These four institutions are run by the members of the Board of Directors elected by the members of the respective organizations, who
