Highly polluting crackers, including illegally imported Chinese products with a deceptive 'Made in India' label, continue to inundate the market. Moreover, doubts persist regarding the actual efficacy of so-called green alternatives in mitigating pollution. The designated two-hour window for bursting crackers also proved futile due to lax enforcement.
